I understand my script titled (the "Work") may be utilised in the production of the film titled, to be directed and produced by

1. Grant of Rights

1.1 I assign the entire copyright whether vested contingent or future in the Work and all rights of action and all other rights of whatever nature in and to the Work whether now known or in the future created to which I am now or may at any time after the date of this Agreement be entitled by virtue of or pursuant to any of the laws in force in any part of the world TO HOLD the same to, their successors and assignees absolutely for the whole period of such rights for the time being capable of being assigned by me together with any and all renewals, revivals, reversions and extensions throughout the world.

1.2 I undertake to do any and all acts and execute any and all documents in such manner and at such locations as may be required by in their sole discretion in order to protect, perfect or enforce any of the rights granted or confirmed to pursuant to this Agreement.

1.3 I agree that any moral or like rights in the Work are irrevocably and unconditionally:
(a) waived; and
(b) I consent to, and will not make any claim in respect of any infringement or contravention of such rights arising from, any alteration to, attribution to the Work as deemed appropriate by, or their nominee,

but only to the extent permitted by law.

2. Warranties to

I warrant, undertake and agree that:

- (a) I am the sole author of the Work;
- (b) I am the sole absolute and unencumbered legal and beneficial owner of all rights of copyright and all other rights whatever in and to the Work throughout the world and have not assigned or licensed any rights in the Work to any person;
- (c) there is no present or prospective claim proceeding or litigation in respect of the Work, any rights in the Work, the title to the Work or the ownership of copyright in the Work which may in any way impair, limit, inhibit, diminish or infringe upon any of the rights in the Work;
- (d) the Work is original to me and does not infringe any right of copyright, moral right, right of privacy, right of publicity, personality or any other right whatever of any other person;

- (e) Metro Screen has the right to use the name and likeness and biography of me in connection with the exploitation by it of the rights assigned pursuant to this Agreement;
- (f) I indemnify and release, their successors, and assignees and its nominees using the Work from any claims, damages, liabilities, costs and expenses arising from use of the Work.
